IMS:





Figure 1: Time of Day

In June the number of Armed Robberies has decreased, but the number of Burglaries has increased drastically with a count of 24 and a total financial loss of approximately R900 000. As illustrated in Figure 1; 11 at night (38%) appear to be the predominant high risk time of day for Burglaries to take place. Gauteng and KwaZulu-Natal accounted for 63% of all the Burglaries for the month of June

"IMS Training has kicked off with a bang in Cape Town, Evander and then Bloemfontein. So far a total of 154 people have been trained. Out of this 154 people 143 were from the Shoprite Checkers Group. We have trained 5 people from Pick 'n Pay, 2 from Jumbo Cash and Carry, 3 from Metro, 1 from Trade Centre. Unfortunately, we had to cancel the Northern Cape training session which was planned to take place in Upington, due to only 4 people booking for the course and thus not justifying the costs to travel there. We have added two new venues to cover a larger part of the Eastern Cape. The two venues are George on 13 September 2005 and we will be in East London on 20 September 2005. Pick 'n Pay also requested that we do an extra session for them in Cape Town on 06 September 2005 for ±35 Pick 'n Pay Stores. 1. What is your role and objective in the CGC Crime Prevention organization?

To organize the industry to share all relevant non competitive crime prevention information in order to prepare the industry to be proactive against all forms of crime that affect it.

I started the programme, when Whitey Basson asked to look at doing something about the crime in Shoprite Checkers group in Oct 2000.

3. What has been the most effective initiative launched by the Programme

To get all the CEO's in the retail & wholesale industry to agree to commit to the programme for a minimum of 5 years. To lend their influence across the industry and to encourage through their networks, for us to involve the entire industry, we manage that process on behalf of the industry.

4. Where do you see the Programme developing in the future?

At this stage we probably have a 55% of participation from the industry, we need to get it to 100%, that will take another 2 to 3 years. We need to be the leaders in fighting crime and be an example to all other industries in SA. We need to be the catalysts and connectors to make all industries committed to share all they know in the fight against crime, this must be done under the auspices of Business Against Crime South Africa (BAC)
